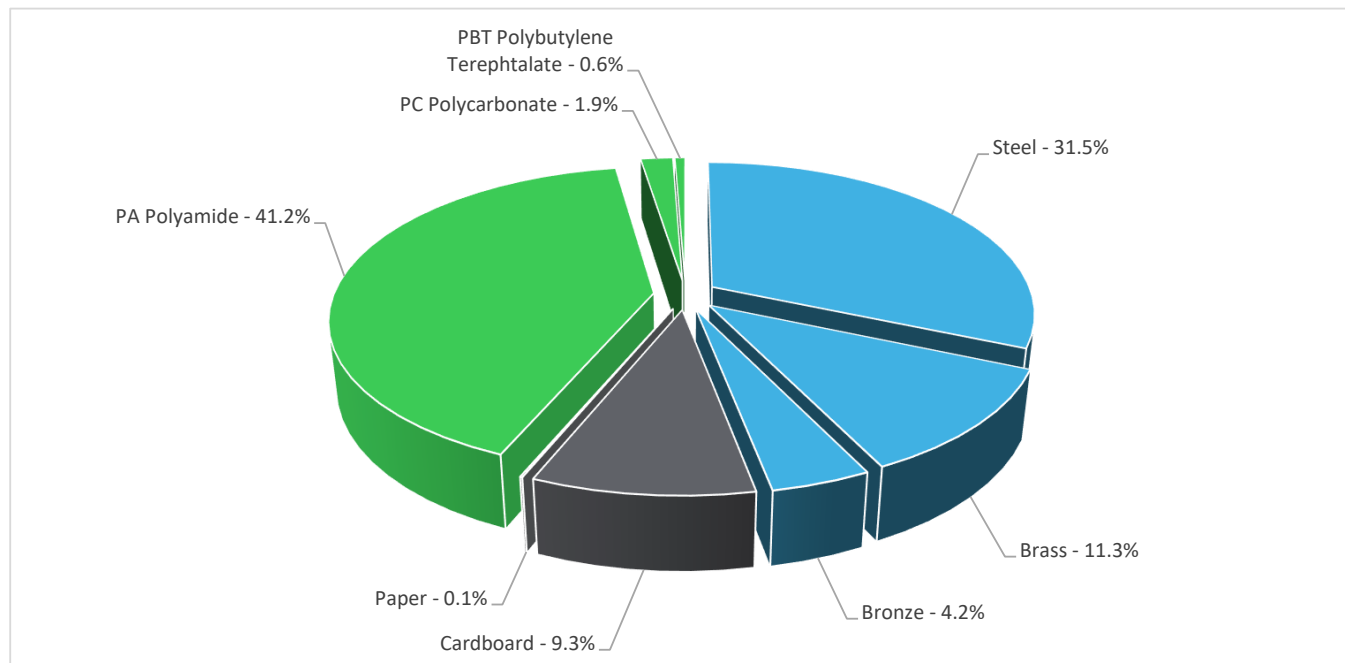
## General information

<b>Representative product</b>	OCEAN PLASTIC DOUBLE SOCKET OUTLET - EKO30017
<b>Description of the product</b>	The main purpose of the Elko Plus Socket product is to connect/disconnect the plug of a load protecting user from direct contact.
<b>Functional unit</b>	Connect/Disconnect during 20 years the plug of a load consuming 16A under a voltage of 250V while protecting the user from direct contact with live parts and with a protection class IP20 in accordance with the standard IEC 60529.

## Substance assessment

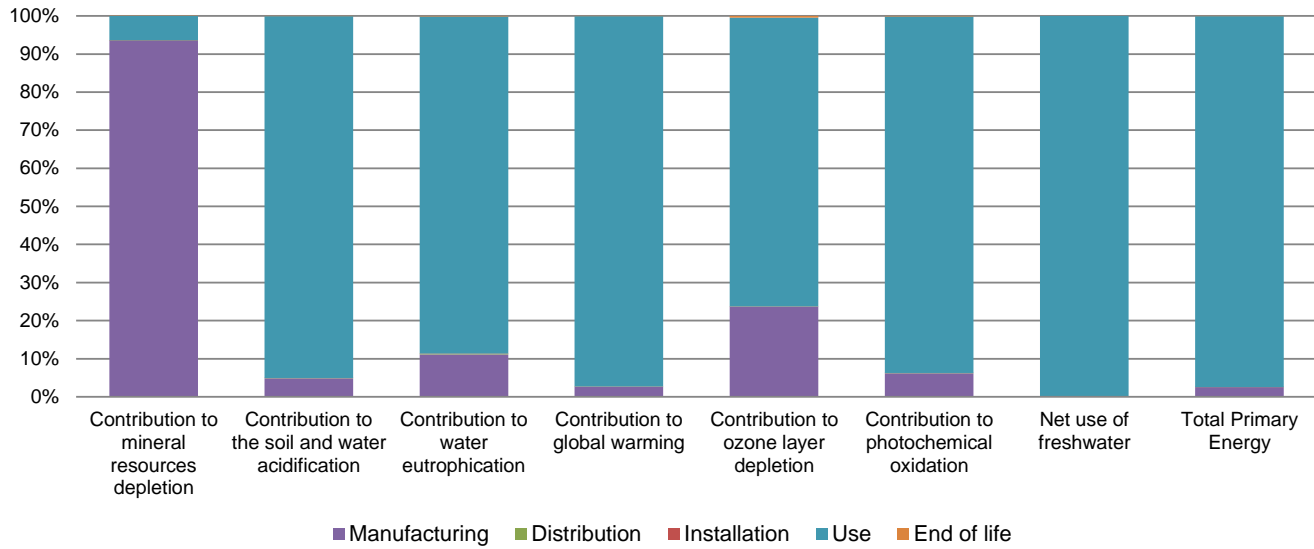
