Effective July 1st, 2006, the European Directive 2002/95/EC –“Restriction of Hazardous Substances” (RoHS), its recast 2011/65/EU of June 8th, 2011, the Delegated Directive (EU) 2015/863 of March 31st 2015, restrict the use in Europe in certain electrical and/or electronic equipment’s of lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE) flame retardant, and from July 22nd 2019, Bis(2-ethylhexyl) phthalate (DEHP), Butyl benzyl phthalate (BBP), Dibutyl phthalate (DBP), Diisobutyl phthalate (DIBP).
