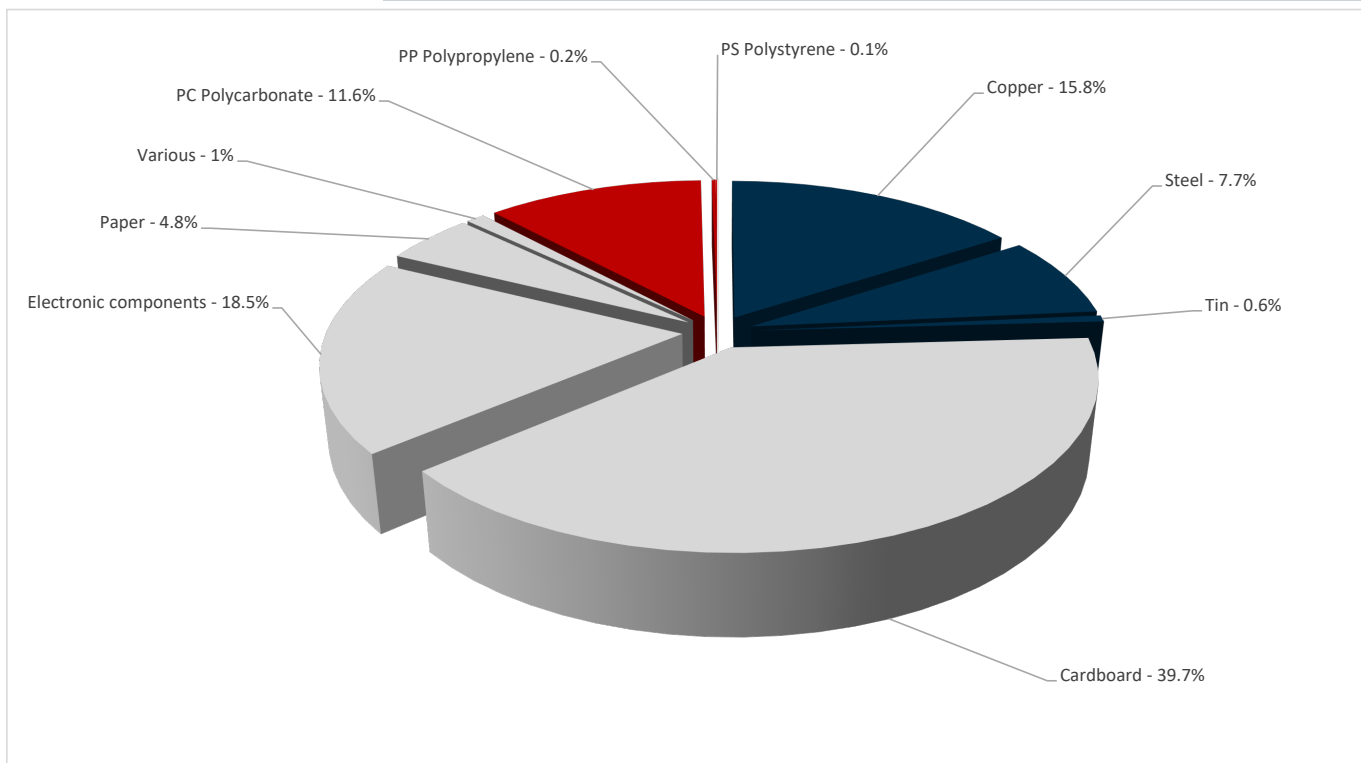


## General information
